



## **Crestwood Chula Vista Core Program**

Crestwood Chula Vista is a Mental Health Rehabilitation Center (MHRC) licensed by the California Department of Health Care Services: Mental Health Division, delivering treatment and care based on the philosophy that mental health recovery is not only possible, it is the goal of our program. We are a 40-bed campus, with all 40 beds contracted through San Diego County. The clients receiving care here are between 18-64 years of age. Crestwood Chula Vista is a 24-hour, 7-day per week provider of care.

Crestwood Chula Vista provides a psychosocial rehabilitation program where clients experience real life demands in a secure and supportive environment. The Center enables clients the ability to cope with their symptoms in daily challenges of life. The focus is to help the client build strengths, self-reliance and independence with training and support.

### **Entry to Program:**

All clients receiving services at this campus are from San Diego County. They are referred and screened for admission following our Screening and Access to Services Policy and Procedure.

### **Program Goals:**

- Assist clients in identifying their needs and areas of improvement.
- Identify clear, specific, and reasonable objectives of treatment.
- Provide behavioral support that is consistent with the tenants of psychosocial rehabilitation and recovery principles.
- Support each client in building strength, self-reliance, and independence.
- Encourage and foster client, facility, agency, and family involvement in the overall treatment plan.
- Establish overall expectations for discharge.
- All care is provided by the facility.

### **Tools Utilized to Accomplish Program Goals:**

- Provide a psychosocial milieu that fosters active participation in the program, self-sufficiency, and independence.
- Provide a structure of support and education that allows the client to modify and manage their symptoms and behaviors, impacting stability.
- The program utilizes healing arts, life skills, and pre-vocational training as guides and opportunities for greater self-expression, self-confidence and meaningful accomplishments.

- Dual recovery, WRAP, anger management, medication education, impulse control, symptom management, DBT skills training groups and leisure skills are all components of Crestwood Chula Vista's group schedule.

**Transition and Discharge Criteria:**

- Medication adherence and knowledge of prescribed medications and their uses.
- Abstinence of excessive behaviors for 30 days.
- Participation in required weekly group hours for 30 days.
- Insight into the issues that brought the client into the facility and a plan to succeed in the community or at a lower-level of care.
- Health and wellness plan, including minimal level of self-care.

**Staffing:**

Crestwood Chula Vista is staffed with Mental Healthcare professionals 24 hours a day, in compliance with State Regulations. Below is a sampling of the disciplines of staff we have at this campus.

**Licensed Nursing staff:** 24 hrs. a day and 7 days a week, including Registered nurses, Licensed vocational nurses and Psychiatric Technicians.
